
If the number of applicants exceeds the ratio of 1:5 for the posts of (1- Scientist B (Medical), 2 Scientist B (Non-Medical), and, 3- Research Assistant), a written examination consisting of 30 marks instead of an interview will be conducted.

Terms and Conditions:

1. The candidate must be a permanent resident of U.T of Jammu and Kashmir.
2. Canvassing in anyway will lead to disqualification of the concerned candidate.
3. All the posts will be on a contract basis for a period of one year initially extendable on the basis of satisfactory work and conduct reported by the Principal Investigator.
4. The selected candidates shall have to submit an undertaking in the shape of affidavit duly attested by the 1st class magistrate to the effect that:-
 - I. The candidate should be a permanent resident f J&K,
 - II. I will adhere to the roster of duties to be issued by the Administration.
 - III. If the documents filed by me are found wrong/incorrect at any point of time my appointment shall be cancelled.
 - IV. I will not participate in any kind of strike/ Protest against the Administration during my tenure in the college
 - V. He/ she has not appointed in any govt./ Semi Govt. Department and is not working there at present.
5. In-service candidates are not eligible to apply.
6. The posts are on contractual basis and temporary; do not confer any right for the selected candidates to the permanent absorption in the department.
7. No TA/DA will be paid for attending the interview/written test. Candidates should bring all the original certificates of educational qualifications, copies of research publications and experience certificate, Identity proof along with two photographs and a set of self- attested photocopies of all certificates and relevant documents (Date of Birth and Domicile) at the time of interview (if any).
8. The decision of the selection committee regarding appointment of candidate will be final and no representation will be entertained in this regard.
9. Selection committee reserves all right to change the selection procedure, rules & cancellation of rules.
10. Govt. Medical College, Baramulla deserves the right to terminate from the job at any time, if the performance of the selectee is not upto the expectation level as and if reported by the Principal Investigator. If the candidate wants to resign a notice period of 30 days is must.
11. In case of adverse report about his/her character and antecedents is received from the inspector General of Police (CID) J&K the candidate shall have no right to claim his/her appointment and his/her appointment as such shall be deemed to have been cancelled ab-intio.
