

- The candidates need to submit an affidavit duly attested by First Class Magistrate at the time of joining. The format is enclosed as Annexure "B".



#### Terms and Conditions: -

- Candidates applying for the post should not be more than 63 years of age as on the date of issuance of notice.
- The appointment under these rules shall not entitle the appointee to any preferential claim for regular appointment. Candidates applying for the post should not be more than 63 years of age as on the date of issuance of notice.
- The appointment on academic arrangement basis of the appointee shall be terminable on either side by prior notice of one month or on payment of one month's salary by the appointing authority:

Provided that the appointment of the appointee shall be terminable without notice by the appointing authority whenever the post is filled up under rules and the appointee shall have no claim against the Government or the appointing authority.

Provided that the appointment on academic arrangement basis against the faculty posts in the Medical Colleges shall terminate on the attainment of 70 years of age by the appointee except for the faculty posts of the Department of Dentistry in the new Medical Colleges and the faculty posts of Dental Colleges and Ayurvedic and Unani Medical Colleges, whereit shall stand terminated on attainment of 65 years of age by the appointee.

- 5. That the appointee shall be entitled to a casual leave of 15 days for the period of one year. Any leave beyond that period, on whatever ground it may be, shall be at the discretion of the appointing authority on justified grounds.
- 6. That, if the appointee at any time wilfully neglects or refuses to perform his/her duties, the appointing authority shall immediately terminate his/her appointment on academic arrangement basis without any notice and he/she shall not be entitled to any salary for such period.
