- ii) A minimum of ten years of teaching and/or research and/or extension experience in the University as Assistant Professor-cum-Jr. Scientist/Associate Professor-cum-Senior Scientist/ Professor-cum-Chief Scientist, and/or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate or 05 post-graduate students.

Academic / Research / Extension Score obtained as per **Annexure** to this Notification by a short-listed candidate called for the interview shall have a weightage of 80/100 marks (80%) and 20/100 marks (20%) shall be for interview before the prescribed Selection Committee.

The candidate's ability for teaching, research and extension appditude shall be assessed through a seminar/lecture in a classroom situation or discussion during the interview.

- **7. Organizational skills:** Significant contributions to overall institutional growth through scholarly output, developing policy frameworks, and having represented institution at national and international platforms



10. The Research score for research papers would be augmented as follows:

Peer-Reviewed or NAAS rated or UGC-listed Journals (Impact factor to be determined as per Thomson Reuters list):

a.	Paper in refereed journals without impact factor	= 5 Points
b.	Paper with impact factor less than 1	= 10 Points
c.	Paper with impact factor between 1 and 2	= 15 Points
d.	Paper with impact factor between 2 and 5	= 20 Points
e.	Paper with impact factor between 5 and 10	=25 Points
f.	Paper with impact factor >10	= 30 Points

- i. Two authors: 70% of total value of publication for each author.
- ii. More than two authors: 70% of total value of publication for the First/Principal/Corresponding author and 30% of total value of publication for each of the joint authors.
- 11. Joint Projects: Principal Investigator and Co-investigator would get 50% each.
- 12. Paper presented if part of edited book or proceeding then it can be claimed only once.
- 13. For joint supervision of research students, the formula shall be 70% of the total score for major advisor and 30% of the total score advisory committee members.
- 14. *For the purpose of calculating research score of the teacher, the combined research score from the categories of 5(b). Policy Document and 6. Invited lectures/Resource Person/Paper presentation shall have an upper capping of thirty percent (30%) of the total research score of the teacher concerned.
- 15. The research & extension score shall be from the minimum of three categories out of seven categories (categories 1 to 7).
- 16. The extension score shall be from the minimum of three categories out of seven categories (categories 1 to 7). Category 7 is the compulsory category for the scientists working in extension system of the university
- 17. Academic/Research/Extension Score = 100
- 18. Academic /research /extension score will have a weightage of 80% (80/100) and interview a weightage of 20% (20/100)
