Whereas, the posts were advertised, vide Notification No. 07-PSC (DR-P) of 2023 dated 01.03.2023; and

Whereas, the Higher Education Department, vide letter No.HED-GAZ/85/2022-04 dated 13.04.2022, among others, again referred 03 posts (OM=01, RBA=01, SC=01) of Librarian, in GECT, in Higher Education Department to the J&K Public Service Commission for selection; and

Whereas, the posts were advertised, vide Notification No. 11-PSC (DR-P) of 2023 dated 05.04.2023; and

Whereas, the written test was conducted on 09.06.2024 and the result thereof was notified vide Notification No. PSC/Exam/S/2025/05 dated 25.01.2025; and

Whereas, Provisional Select List was issued on 11.04.2025 and 28.04.2025; and

Whereas, the Selection Lists were provisional, subject to objections, if any, which were to be received within five days;

Whereas, four representations have been received, from:-



As per my OMR sheet and answer key uploaded on official website i was anticipating a higher score than what is reflected in the Provisional selection list and has requested to look into this matter.	The representation is based on presumptions and without any documentary evidence.
03	Mr. Shaib and others	We are writing this application to bring to your kind notice a matter of serious concern regarding the document verification process for the post of Librarian at GCET. It has come to our knowledge that one of the applicants, namely Mashood Yousuf Khan, bearing Application No. 23011140300070 and Roll number 9000081, has allegedly submitted fake and backdated research papers/publications during the document verification phase against the advertisement notice 11-PSC (DR-P) OF 2023 dated: 05.04.2023. These publications appear to have been manipulated or possibly published post facto with backdated entries to fulfill the eligibility or merit criteria. Such actions, if proven true, not only violate the principles of	The allegation is without any documentary evidence. Evaluation of Special Attributes is the domain of subject matter experts whose recommendations are accepted by the Commission. Moreover, Mr. Mashood Yousuf Khan has not made to the Select List.

04	Mr. Mashood Yousuf Khan	<p>There is inconsistency in the selection process conducted by JKPSC for the post of College Librarian in the Higher Education Department, under the two aforementioned notifications, which has resulted in an overlapping of selected candidates and denial of rightful opportunity to eligible candidates like myself.</p> <p>1. kindly Review and rectify the final selection process for Notification No. 11-PSC(DR-P) of 2023 (GCET), and exclude already selected candidates from Notification No. 1 from being counted again for Notification No.</p> <p>2. Consider my candidature for appointment against the post under Notification No. 2, being next in the order of merit and having duly qualified.</p> <p>3. Pending consideration of this representation, kindly withhold the final recommendation and appointment process to prevent irreparable harm.</p>	<p>The Notifications pertain to two different dates of advertisements, as such separate Provisional Select Lists have been notified.</p>
